This is the terms & policy that is agreed upon when you are creating an account. The document will explain the terms that you agree to when using the Social Cooking (SoCo) application. It will then explain how we collect and process user data, also how you can delete your account and remove all data related to you.

About the application:

Social Cooking aims to be “the” platform for managing recipes, getting inspired about food, and to ease your shopping with grocery lists.

When you are first creating your account, you will get your very own digital cookbook. You can modify every recipe that you’ve added to your cookbook, to give your recipes a touch of you. Share your favorite recipes with friends and family.

## Terms to use the app

The application is free to use and does not include any hidden costs.

If terms are breached, we may disable your account and delete inappropriate content.

By creating an account with the Social Cooking app (SoCo), you agree to the following:

- Use your given name
- Add correct information regarding yourself
- Use the app in the way it’s intended to be used
- Not upload or add any image or information not owned by you

## **What data do we collect?**

SoCo collects the following data:

- We store the data that you add into the app; recipes, grocery lists, user settings, meals, groups, followers, following, events, and invitations for meals.
- We collect Events; information of the recipes that you have viewed to enable proposal of recipes you may like.

## **How do we collect your data?**

You directly provide SoCo with most of the data we collect. We collect data and process data when you:

- Voluntarily add or change recipes, grocery lists, user settings, meals, groups, followers, following as well as make invitations for meals.
- Events are collected when you click on a recipe or perform a search

## **How will we use your data?**

SoCo collects your data so that we can:

- Enable you to use your data on different devices and have a secure backup in the cloud.
- To give personalized recommendation on recipes that you may like

## **How do we store your data?**

SoCo securely stores your data at Amazon AWS.

SoCo will keep your recipe, meals and profile data until you remove your data or ask SoCo team to remove it for you.

## **What are your data protection rights?**

SoCo would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request SoCo for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that SoCo correct any information you believe is inaccurate. You also have the right to request SoCo to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that SoCo erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that SoCo restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to SoCo's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that SoCo transfer the data that we have collected to another organization, or directly to you, under certain conditions.
